
# REAL» SWITCH CHALLENGE

United States and Canada Rules



# Three Steps to a Real Reward

- **1) Join the Challenge** Pick your pack; pick your order (Auto Order).
- **2) Build Your Team** in your first full Business Period (BP) immediately following your enrollment and earn product valued at approximately \$60 usd. *A Team consists of four (4) sponsored or six (6) Qualified Associates (no more than three (3) in one (1) leg).*
- **3) Build Your iTeam** by the end of your first three (3) full BPs immediately following your enrollment to qualify for an iPad 2°. An iTeam consists of fourteen (14) Qualified Associates (no more than eight (8) in one leg).

# **Existing Associates**

When you enroll two (2) NEW Associates in two (2) separate legs by the end of BP 13, 2011 and they take the Real Switch Challenge and qualify for their iPads, you will also earn your own iPad 2.

## **NEW vs. EXISTING ASSOCIATES**

- 1) NEW ASSOCIATE—Any Associate enrolled from BP 8, 2011 (July 9, 2011) and beyond
- **2) EXISTING ASSOCIATE**—Any Associate enrolled prior to BP 8, 2011 (July 9, 2011)
- 3) POSITION TRANSFERS—For the purpose of this incentive, the original enrollment date of the Position will determine if the Position will be considered as NEW or EXISTING.
- 4) TERMINATED/RE-ENROLLED ASSOCIATES
  - a. If an Associate terminates his/her account (after a minimum of 6 months inactivity) and re-enrolls in a new position, he/she will be considered a NEW Associate.
  - b. You may ONLY count a maximum of six (6) of these Associates toward your iTeam to earn an iPad 2 mobile digital device.

### 5) MEMBERS

- a. Members are retail customers and do not participate in the Mannatech Career and Compensation Plan.
- b. Member orders WILL NOT count toward your iTeam qualification.
- 6) GROUP QUALIFICATION—Your 14 Qualified Associates (iTeam) must all have a qualifying order in the same BP to count for the incentive.

All discrepancies must be received by Mannatech's Incentives Department within 30 days of the close of your three (3)-BP Qualification period. Any discrepancy received after the 30 Days will not be considered for approval.
- **4)** All determinations/decisions as to awarding the iPad are solely at Mannatech's discretion.

# **GENERAL RULES**

### PRODUCTS EARNED

- 1) Must build a team in your first BP. A team consists of four (4) sponsored or six (6) Qualified Associates (no more than three (3) in one leg).
- 2) Must be on an Automatic Order to qualify.
- **3)** Product will be shipped with the next Automatic Order with no additional charge.
- **4)** Product cannot be exchanged or returned for a refund.

## iPAD REWARD

- The Real Switch Challenge Incentive Package will be awarded to the Contest Qualifier named on the Mannatech account at the end of the three (3)-BP qualification period.
- Due to many state laws and federal regulations, ALL participants MUST BE 18 years of age or older at the time of enrollment.

- 3) Only one (1) iPad award may be earned per Tax ID number. In no event may any Associate's Tax ID number earn more than one (1) iPad.
- 4) If a shared position qualifies for the Real Switch Challenge Incentive Package, only one iPad will be awarded. Each person listed on the account is not entitled to an iPad.
- 5) Mannatech, in its sole discretion, reserves the right to substitute the Real Switch Challenge Incentive iPad for a prize of equal or greater value for any individual Contest Qualifier or the entire group of Contest Qualifiers.
- 6) Mannatech will ship the iPad within 30 days after receiving the online age verification. The iPad will be shipped to the shipping address listed on the account, signature required. If the iPad is returned for any reason, the award may be forfeited.
- 7) Participants must meet all eligibility requirements. Mannatech's determinations and decisions are final on all matters related to this Incentive Program.
- 8) If the Qualified Associate chooses not to accept the Incentive Package earned, no cash will be awarded and the prize will be forfeited.

**Associates, New**—Any NEW Associate who purchased a Preferred or All-Star level pack as of BP 8, 2011 (July 8, 2011)

**Associates, Existing**—Associates with original enrollment dates prior to July 8, 2011 (BP 8, 2011).

Associates in Good Standing—Only active Associates in Good Standing during the Contest Period and when prizes are awarded are eligible to enter or receive a prize. An "Associate in Good Standing" is one who has (1) renewed his or her position as required by the Company and (2) has not received a final compliance sanction precluding the Associate from participating in events and/or receiving recognition.

**Qualifying Order**—An order that has a minimum of 100 Qualifying Volume.
