- **Term:** The 90 Days to Ū<sup>th</sup> Contest begins July 9, 2015 and ends April 6, 2016. Information on how to enter and prizes are included in these rules. By submitting an entry, each Participant agrees to the Rules and warrants that his or her entry complies with all requirements set out in the Rules. This is a judge-based contest and chance plays little to no part in the determination of winners. Participants can only win one of the 90 days to Ū<sup>th</sup> contests, but all winners are eligible for the grand prize.
- **Eligibility Requirements.** This is only open to Mannatech Associates and Members in Good Standing<sup>1</sup> who are: (a) at least 18 years of age as of July 9, 2015 (must be 19 or older in states or provinces where the age of majority is 19); and (b) legal residents of the United States or Canada (excluding Quebec). <sup>1</sup> Only active and Qualified Associates (Associates who have a minimum of 100PV in each of the qualifying business periods) and in Good Standing during the qualification periods and when prizes are awarded are eligible to enter or receive a prize. An Associate in “Good Standing” is one who has renewed his or her position as required and is not the subject of a final Compliance Committee disposition (i.e., the appeal period has expired and/or a final compliance appeal disposition has occurred). See Associate Disciplinary Procedures in sections 6.12 and 6.13 of the Associate Policies and Procedures.
